Therefore, we present to you the criteria of Accreditation below, these criteria were used for the previous accreditation exercise and were accepted by SSC NCAP Division:

NCAP TECHNICAL LEVEL	Minimum Qualification
Level 1	1. SKF 1 and 2 Dan PLUS 2. Any 1 of the followings: a. At least 2 years (consecutively) as an instructor b. Officiated as Judge in LOCAL tournament for 2 consecutive years
Level 2	1. SKF 3 to 4 Dan PLUS 2. Any 1 of the followings: a. At least 4 years (consecutively) as an instructor. b. Participated or Officiated in SKF / Own Style tournament for 2 consecutive years
Level 3	1. SKF 5 Dan and above PLUS 2. Any 1 of the followings: a. At least 6 years (consecutively) as an instructor b. Officiated in SKF tournament / Own Style Tournament for 2 consecutive years c. Organized or assisted in any regional tournament in past 5 years

Payment for each level:

Level 1	S \$50.00
Level 2	S \$75.00
Level 3	S \$100.00

Kindly disseminate this information to any one who is interested in the Accreditation Exercise. The closing date for this Exercise is **30th September 2006**. Please note that late comers will not be entertained.

For submission, kindly use the attached application form, the application must enclosed the following documents:

1. Copies applicant's dojo Dan Certificate.
2. SKF Dan Certificate for verification (*Applicants who have applied for Federation Dan and been approved without having the Dan Certificate, may get verification letter from Dan Conversion Committee first in their application, then submit the said copy to us for filing*)
3. Evidence on Instructorship / Organisational Skill (Such as Participation Cert, Instructor Cert, etc.)
4. A Cross cheque bearing the required amount according to the level of accreditation, and make payable to '**SINGAPORE KARATE-DO FEDERATION**'.
